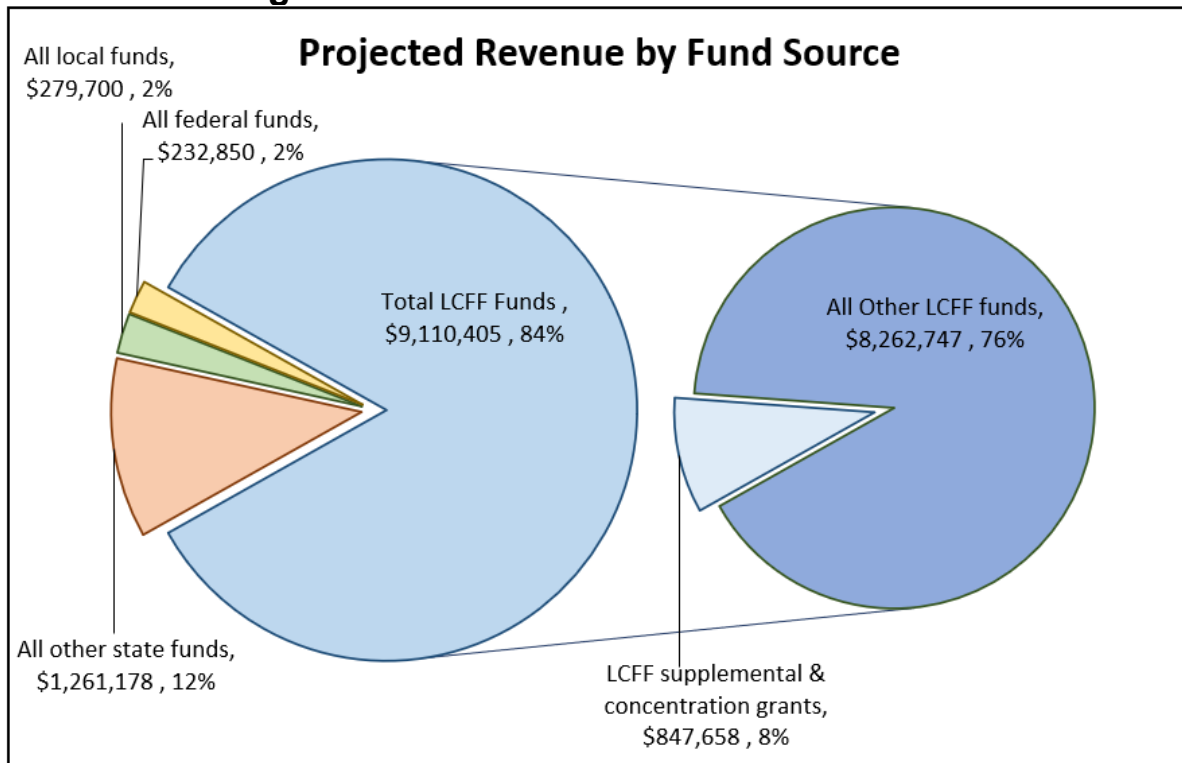

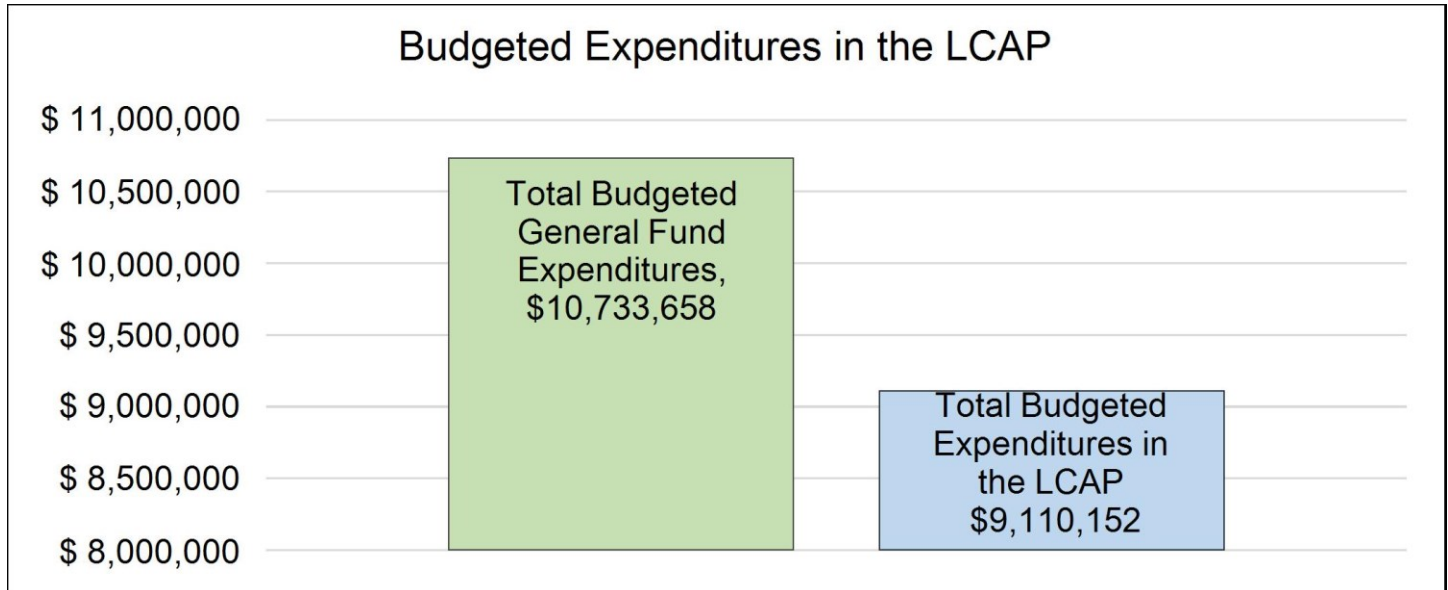


This chart shows the total general purpose revenue NextGeneration STEAM Academy expects to receive in the coming year from all sources.

The text description for the above chart is as follows: The total revenue projected for NextGeneration STEAM Academy is \$10,884,133, of which \$9,110,405 is Local Control Funding Formula (LCFF), \$1,261,178 is other state funds, \$279,700 is local funds, and \$232,850 is federal funds. Of the \$9,110,405 in LCFF Funds, \$847,658 is generated based on the enrollment of high needs students (foster youth, English learner, and low-income students).

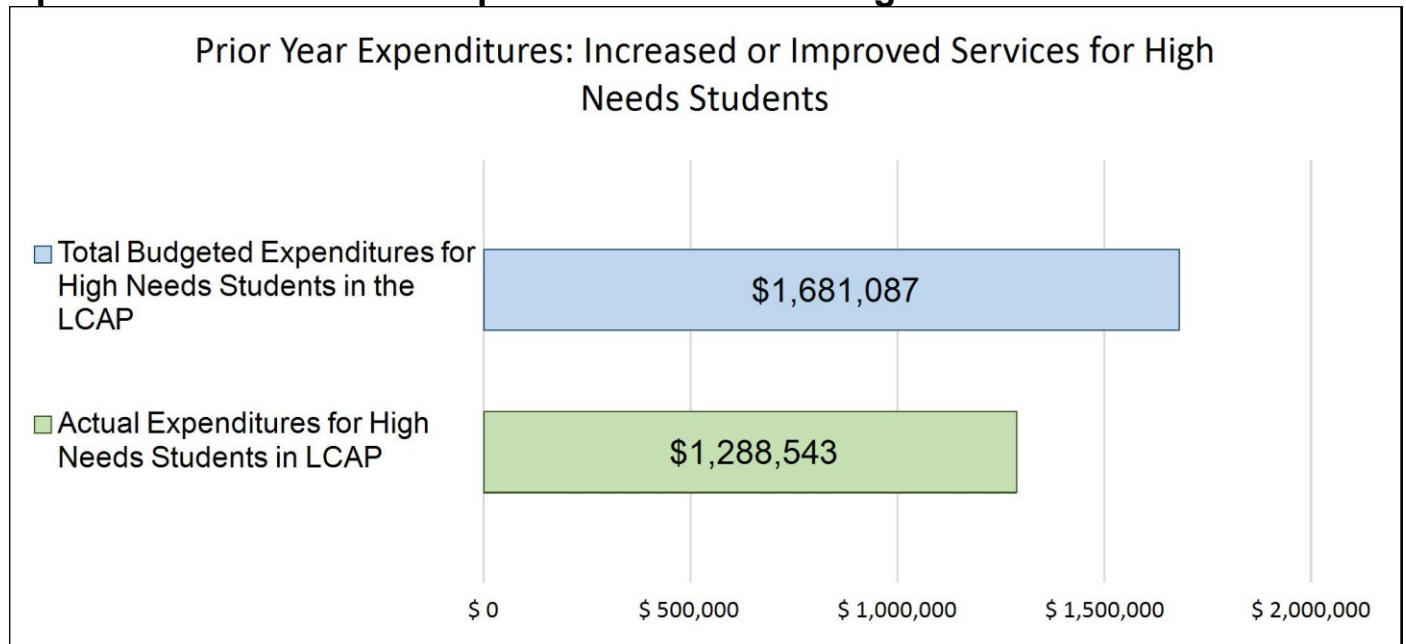

Increased or Improved Services for High Needs Students in the LCAP for the 2024-25 School Year

In 2024-25, NextGeneration STEAM Academy is projecting it will receive \$847,658 based on the enrollment of foster youth, English learner, and low-income students. NextGeneration STEAM Academy must describe how it intends to increase or improve services for high needs students in the LCAP. NextGeneration STEAM Academy plans to spend \$1,690,944 towards meeting this requirement, as described in the LCAP.

This chart compares what NextGeneration STEAM Academy budgeted last year in the LCAP for actions and services that contribute to increasing or improving services for high needs students with what NextGeneration STEAM Academy estimates it has spent on actions and services that contribute to increasing or improving services for high needs students in the current year.

The text description of the above chart is as follows: In 2023-24, NextGeneration STEAM Academy's LCAP budgeted \$1,681,087 for planned actions to increase or improve services for high needs students. NextGeneration STEAM Academy actually spent \$1,288,543 for actions to increase or improve services for high needs students in 2023-24.

The difference between the budgeted and actual expenditures of \$-392,544 had the following impact on NextGeneration STEAM Academy's ability to increase or improve services for high needs students:

STEAM Academy met the increase or improved service obligation for our high needs students as we had budgeted for services over the amount of supplemental/concentration funds actually received. STEAM had planned to hire an Intervention Teacher for the 23.24 school year to work with primary students who were struggling in the area of reading. We were unable to hire and fill this position for this past school year. While having this dedicated position would provide targeted services to high need students, teachers were able to continue to work with their students within their classrooms and also focus on these students in their weekly tutoring sessions. We will continue to attempt to hire for this position in future years. There had also been a plan to have an additional Program Administrator to coordinate and focus on services for high needs students. We were unable to fill the position for 23.24, and the services provided by this position were split between the other 2 site Administrators.

A description of any substantive differences in planned actions and actual implementation of these actions.

Goal 1 was fully implemented with no substantive differences. All of the planned actions in Goal 1 were implemented. The professional development in A/S 1.8 focused on Math, implementing our new science curriculum, TWIG, and Socio-Emotional Health.

An explanation of material differences between Budgeted Expenditures and Estimated Actual Expenditures and/or Planned Percentages of Improved Services and Estimated Actual Percentages of Improved Services.

We have established that any difference of \$50,000 +/- between the budgeted expenditure and the actual estimate would be considered a material difference. The following actions/services fall in that category:

A/S 1.1 Academies Staff- It appears there is a material difference but the costs were calculated incorrectly. The true estimated amount should have been 649,154 and the estimated actual expense is 646,668.84 which is not a material difference.

A/S 1.2 Academies Facilities & Operations- The budget for Gas & Electricity within this action, was higher what was actually spent this school year.

All of the other actions/services in Goal 1 were implemented and provided within the range set for material difference.

An explanation of how effective or ineffective the specific actions were in making progress toward the goal during the three-year LCAP cycle.

All of the actions were needed and effective in meeting the goal and the needs of the organization. Transparency continues to be a goal so our partners are fully aware of our programs and expenditures.

Specifically A/S 1.8, our website and app, aided us in continuing progress towards our goal of being transparent and ensuring they feel a part of the school community.

There were no changes made to goal 1 or its metrics.

We have changed A/S 1.9 to not only include our Compliance Training Program, but also our new HR management program, Frontline. This tool will enable our district office to streamline HR processes, have accessible, accurate records, and communicate with staff regarding their documentation.

The majority of Actions/Services in Goal 2 were implemented as planned and without interruption. The following A/S had a change or delay from the original plan:

2.8- We provided in house training for our support personnel this school year. We have planned to have our support personnel receive training from SJCOE in the 24-25 school year as they have in previous years.

2.15- We were unable to fill the Reading Intervention position for the 23-24 school year. We are hopeful we will be able to fill the position in the 24-25 school year.

An explanation of material differences between Budgeted Expenditures and Estimated Actual Expenditures and/or Planned Percentages of Improved Services and Estimated Actual Percentages of Improved Services.

We have established that any difference of \$50,000 +/- between the budgeted expenditure and the actual estimate would be considered a material difference. The following actions/services fall in that category:

A/S 2.5: We had planned for more paraprofessional and instructional aide positions than what we were able to fill.

A/S 2.7: The costs of curriculum were more than estimated based on additional classes that were added. We also piloted and began to purchase materials for a new math curriculum this school year.

A/S 2.9: The costs of computers for students and staff was more than what we had anticipated.

A/S 2.15: We were not able to fill the Reading Intervention position this school year.

All of the other actions/services in Goal 2 were implemented and provided within the range set for material difference.

All of the actions were needed and effective in making progress towards Goal 2.

A/S 2.13 which is tied to our current local assessment, NWEA has been a great tool to gauge student success throughout the school year and to be able to provide individualized instruction.

A description of any changes made to the planned goal, metrics, desired outcomes, or actions for the coming year that resulted from reflections on prior practice.

There are no changes to the goal, metrics, or desired outcomes for Goal 2. There are a few changes to the action items, as listed below:

A/S 2.4 Job Fairs & Recruitment has been combined with A/S 1.5 to account for Academies and site specific marketing costs.

As our school site is growing in numbers, we have begun to hire some Special Education Services Staff instead of contracting out. To show that distinction from contracted services in Goal 1, we created A/S 2.17.

Funds for Action 2.6: Resident, Intern, and Induction Programs have been increased to account for the full amount of induction costs.

Funds for Action 2.7: Core and Supplemental Curriculum have been increased to fund the continued roll out of the new science curriculum and a new math curriculum.

Reflections: Annual Performance

A reflection on annual performance based on a review of the California School Dashboard (Dashboard) and local data.

One of the biggest successes of STEAM Academy is the progression in academic areas as verified by state assessment scores. Our CA Dashboard results showed that in the Spring of 22-23 our ELA performance increased 5.9 points and our Math performance increased 11.4 points. We are also proud to continue to bring back extracurricular services for students and school-wide events for our community. We had students participate in sports teams, academic teams, and leadership activities. According to our student survey, 92% of students agree that STEAM Academy wants students to succeed and 94% try their best in school. We will continue to focus on encouraging parents and families to come and participate in school activities. We will continue to send out monthly school wide newsletters, weekly newsletters from teachers, and regular communication on student specific needs. This year, over 200 family members volunteered on campus as verified by our Raptor check in system.

One identified need based on Dashboard Data is Student English Language Acquisition. To increase our English Learner progress, we will continue to encourage teachers to utilize the ELD standards that are embedded within their curriculum to provide their EL students with proper integrated ELD time. In conjunction, students are pulled for designated ELD with our ELD instructional aide. We plan to continue to enforce the importance of integrated and designated ELD to our staff and allow opportunities for our ELD instructional aides across our schools within the academies to collaborate. This collaboration time allows the coordinators to bounce ideas off of each other and come up with the best plan for student growth. In 2022, 37.1% of students were chronically absent and in 2023, 24.5% of students are chronically absent. Although we have made progress, we will continue to make it a priority to lower that number. As we continue to bring back and build out our school-wide events, in person parent teacher conferences, and other opportunities for our school community to build relationships, we anticipate that our attendance rates will return to our previous rate. It is also our priority to continue to communicate with our families whose students are chronically absent. We want families to be reminded of the importance of coming to school every day and to help remove any barriers they may have in sending their child to school. Decreasing our chronic absenteeism rate will continue to be a priority.

We will work as an instructional staff next year to push out resources and tools across grade levels to address this need. We are continuing and expanding the summer session for qualifying students in June 2025. We will plan to hold additional parent information sessions periodically during the school year to provide information/support to parents in areas that are identified as interests or needs.

We also plan to hold meetings at different times of day to see how they impact attendance to inform further decisions. We will survey parents who choose to become part of committees on times that will work best for them to encourage participation and relationship building. Previously action 3.15 was Parent Trainings but we have modified it to also include funds to spend on food, supplies, etc. to increase participation in committee meetings.

STEAM Academy is a single-school Charter with 820 students in grades TK-8. In the 2023-24 school year, 15.3% of students are Multiple Language Learners. The Actions/Service 2.9 described below, is principally directed and most effective in meeting the individual and specific needs of our MLL students.

A/S 2.9 English Learner Services: After reviewing student data, it was determined that English learners were performing below the level of all students in the area of ELA throughout grade levels. To address this concern, an on-line program, LEXIA English, was introduced to use with English Learner to address language acquisition skills. Teachers were trained on how the program works, and ways that they could incorporate in into their daily schedules to ensure that EL students would have consistent use of the program. In addition to the integrated ELD that classroom teachers provide, LEXIA English tracks student progress through use of the program and then groups students for additional designated ELD lessons. A staff member was hired to manage these designated ELD groups, and provide weekly lessons to students to address their specific language acquisition needs and targets. To address the language acquisition needs of students the action is effective by including all instructional staff in on-going monitoring for English Learners. Professional development being provided school wide ensures that all English Learners will be placed with a teacher who has received training on instructional strategies and programs to address their specific learning needs.

- **12. LCFF Carryover — Dollar Amount LCFF Carryover (Subtract 11 from 10 and multiply by 9)**
 - If the Estimated Actual Percentage of Increased or Improved Services (11) is less than the Estimated Actual Percentage to Increase or Improve Services (10), the LEA is required to carry over LCFF funds.

The amount of LCFF funds is calculated by subtracting the Estimated Actual Percentage to Increase or Improve Services (11) from the Estimated Actual Percentage of Increased or Improved Services (10) and then multiplying by the Estimated Actual LCFF Base Grant (9). This amount is the amount of LCFF funds that is required to be carried over to the coming year.
- **13. LCFF Carryover — Percentage (12 divided by 9)**
 - This percentage is the unmet portion of the Percentage to Increase or Improve Services that the LEA must carry over into the coming LCAP year. The percentage is calculated by dividing the LCFF Carryover (12) by the LCFF Funding (9).
