




This chart shows the total general purpose revenue River Islands Technology Academy II expects to receive in the coming year from all sources.

The text description for the above chart is as follows: The total revenue projected for River Islands Technology Academy II is \$13,264,674, of which \$10,875,920 is Local Control Funding Formula (LCFF), \$1,724,563 is other state funds, \$372,855 is local funds, and \$291,336 is federal funds. Of the \$10,875,920 in LCFF Funds, \$817,359 is generated based on the enrollment of high needs students (foster youth, English learner, and low-income students).



The text description of the above chart is as follows: In 2023-24, River Islands Technology Academy II's LCAP budgeted \$1,261,249 for planned actions to increase or improve services for high needs students. River Islands Technology Academy II actually spent \$1,208,851 for actions to increase or improve services for high needs students in 2023-24.

The difference between the budgeted and actual expenditures of \$-52,398 had the following impact on River Islands Technology Academy II's ability to increase or improve services for high needs students:

River Islands Technology Academy met the increase or improved service obligation for our high needs students as we had budgeted for services over the amount of supplemental/concentration funds actually received. The minimal difference was due to slightly lower costs of services, and had no impact on those that were planned and provided.

Goal 1 was fully implemented with no substantive differences. All of the planned actions in Goal 1 were implemented. The professional development in A/S 1.8 focused on Math, implementing our new science curriculum, TWIG, and Socio-Emotional Health.

We have established that any difference of \$50,000 +/- between the budgeted expenditure and the actual estimate would be considered a material difference. The following actions/services fall in that category:

A/S 1.6 SPED Contract Services- The amount we spent to service our SPED students was more than what we had anticipated.

All of the other actions/services in Goal 1 were implemented and provided within the range set for material difference.

All of the actions were needed and effective in meeting the goal and the needs of the organization. Transparency continues to be a goal so our partners are fully aware of our programs and expenditures.

2.8- We provided in house training for our support personnel this school year. We have planned to have our support personnel receive training from SJCOE in the 24-25 school year as they have in previous years.

- A/S 2.5: We had planned for more paraprofessional and instructional aide positions than what we were able to fill.
- A/S 2.7: The costs of curriculum were more than estimated based on additional classes that were added. We also piloted and began to purchase materials for a new math curriculum this school year.

All of the actions were needed and effective in making progress towards Goal 2.

A/S 2.13 which is tied to our current local assessment, NWEA has been a great tool to gauge student success throughout the school year and to be able to provide individualized instruction.

There are no changes to the goal, metrics, or desired outcomes for Goal 2.

A/S 2.4 Job Fairs & Recruitment has been combined with A/S 1.5 to account for Academies and site specific marketing costs.

As our school site is growing in numbers, we have begun to hire some Special Education Services Staff instead of contracting out. To show that distinction from contracted services in Goal 1, we created A/S 2.17.

Funds for Action 2.6: Resident, Intern, and Induction Programs have increased to account for the full amount of induction costs.

Funds for Action 2.7: Core and Supplemental Curriculum have increased to fund the continued roll out of the new science curriculum and a new math curriculum.

3.4 College Bound- College of the Week is usually a part of our Friday Morning Assemblies held in person each week. This year, we tried out new activities to engage students like minute-to-win-it games and presentations from classrooms on different cultures. Our goal for next year is to create a combination of new activities that were successful and continuing College of the Week presentations.

A/S 3.9 was implemented in an awards assembly each trimester that brought the school community together to celebrate students' accomplishments. We were also able to expand our middle school success class offerings to meet students' interests, including an Intro to Spanish class and a River Raptors class.

There are no changes to the goal, metrics, or desired outcomes.

We have combined the Middle School Success Classes and Enrichment Programs action items to make it easier to track the expenses. Some programs offered as Success Classes, like music are also offered as after school Enrichment programs.

We have removed A/S 3.11 Flexible Furniture as we have purchased what we will need for years to come with minimal replacement costs.

A/S 3.6 will now include our Emergency Communication Tool, Catapult, along with school safety equipment.

A/S 3.15 will now include costs for engaging educational partners along with parent trainings offered throughout the school year.

One of the biggest successes of the River Islands Technology Academy (RiTechA) program continues to be the ability to maintain progress in academic areas as verified by state assessment scores. Our CAASPP results from spring 2023 showed that in ELA, 59.71% of students tested were at or above grade level; and in the area of Math, 51.28% of students tested were at or above grade level. Additionally, our efforts in improving our ELD program have shown growth in our Multiple Language Learning students' test scores. According to the 2023 Dashboard, 51.5% are making progress towards English language proficiency. We are also proud to continue to bring back extracurricular services for students and school-wide events for our community. We had students participate in sports teams, academic teams, lego club and leadership activities. We had a lot of parent participation at field trips, school wide events, and in classrooms. As verified by our Raptor check in system, we had 394 cleared volunteers participate this year.

One identified need based on the Dashboard is our chronic absenteeism rate. In 2022, 26.5% of students were chronically absent and in 2023, 19.1% of students are chronically absent. Although we have made progress, we will continue to make it a priority to lower that number. Attendance is very important to River Islands Technology Academy as it was one of our strengths for many years. As we continue to bring back and build out our school-wide events, in person parent teacher conferences, and other opportunities for our school community to build relationships, we anticipate that our attendance rates will return to our previous rate. It is also our priority to continue to communicate with our families whose students are chronically absent. We want families to be reminded of the importance of coming to school every day and to help remove any barriers they may have in sending their child to school.

Increasing English Learner Progress will continue to be a priority. We will continue to have frequent communication and learning opportunities for teachers and parents about how they can support their Multiple Language Learners via staff meetings, ELAC meetings, and newsletters. Additionally, we are in the process of implementing an online data tracking tool to make it easy for staff to see their students' data and ensure that all MLL student files and documentation stay organized.

Students in grade 3-8 completed the online survey independently, while students in grades K-2 completed the survey as a class, led by their teacher who tabulated and reported the results as a class average. Students shared their thoughts on River Islands Technology Academy, their teachers, current offerings, and personal feelings of connectedness, comfortability, and value. The student survey was shared with staff on May 1, 2024 and closed on May 15. Results from the student survey were shared with the LCAP Advisory Committee, the Governing Board, and staff.

On April 25, the committee met to discuss progress on the LCAP and to give in depth feedback of what was being asked on the parent survey. They also looked at and reflected on chronic absenteeism and suspension rate from the Dashboard. They provided successes and needs for the school site based on the data which helped to inform reflections in Local Indicators and actions in the LCAP.

Through feedback, parents expressed the need for a better understanding of ways that they can assist their students with work at home and would like school events to be held at a variety of times so it opens up opportunities for different groups of parents to attend.

We will work as an instructional staff next year to push out resources and tools across grade levels to address this need. We are continuing and expanding the summer session for qualifying students in June 2025. We will plan to hold additional parent information sessions periodically during the school year to provide information/support to parents in areas that are identified as interests or needs.

We also plan to hold meetings at different times of day to see how they impact attendance to inform further decisions. We will survey parents who choose to become part of committees on times that will work best for them to encourage participation and relationship building. Previously action 3.15 was Parent Trainings but we have modified it to also include funds to spend on food, supplies, etc. to increase participation in committee meetings.

River Islands Technology Academy is a single-school Charter with 1038 students in grades TK-8. In the 2023-24 school year, 10.6% of students are Multiple Language Learners. The Action/Service 2.9 described below, is principally directed and most effective in meeting the individual and specific needs of our MLL students.

A/S 2.9 English Learner Services: After reviewing student data, it was determined that English learners were performing below the level of all students in the area of ELA throughout grade levels. To address this concern, an on-line program, LEXIA English, was introduced to use with English Learner to address language acquisition skills. Teachers were trained on how the program works, and ways that they could incorporate in into their daily schedules to ensure that EL students would have consistent use of the program. In addition to the integrated ELD that classroom teachers provide, LEXIA English tracks student progress through use of the program and then groups students for additional designated ELD lessons. A staff member was hired to manage these designated ELD groups, and provide weekly lessons to students to address their specific language acquisition needs and targets. To address the language acquisition needs of students the action is effective by including all instructional staff in on-going monitoring for English Learners. Professional development being provided school wide ensures that all English Learners will be placed with a teacher who has received training on instructional strategies and programs to address their specific learning needs.
