



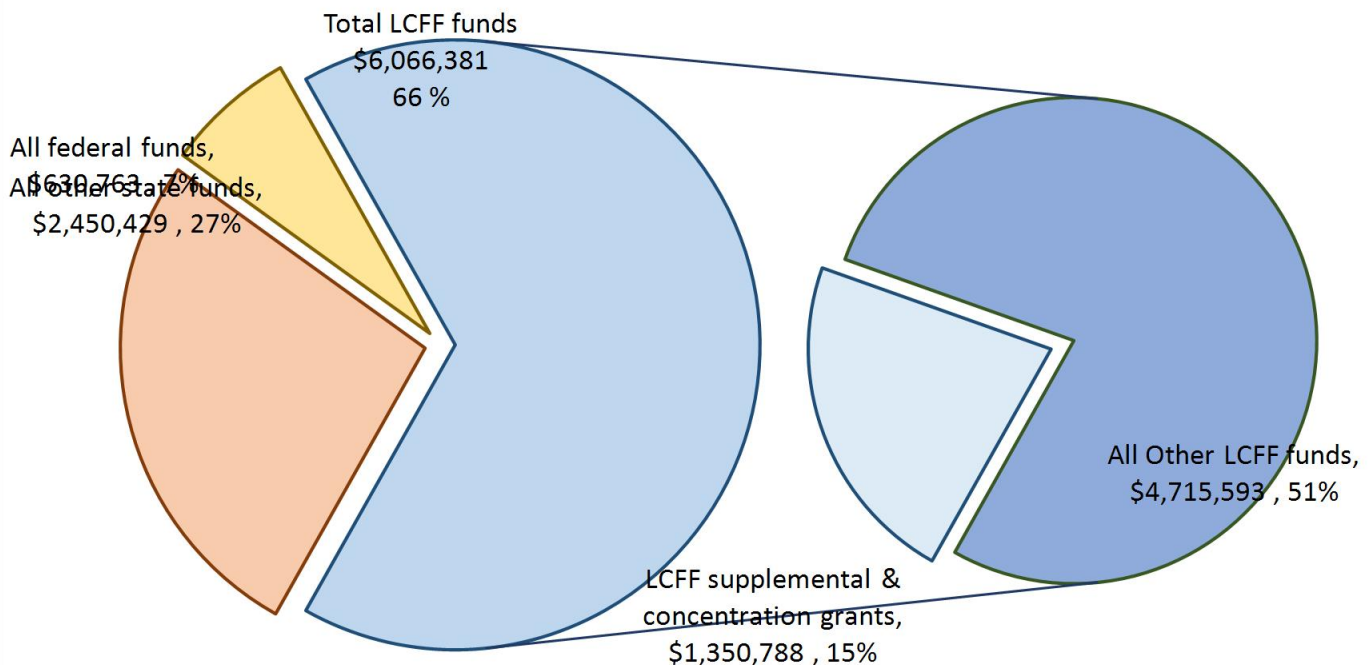

Projected Revenue by Fund Source

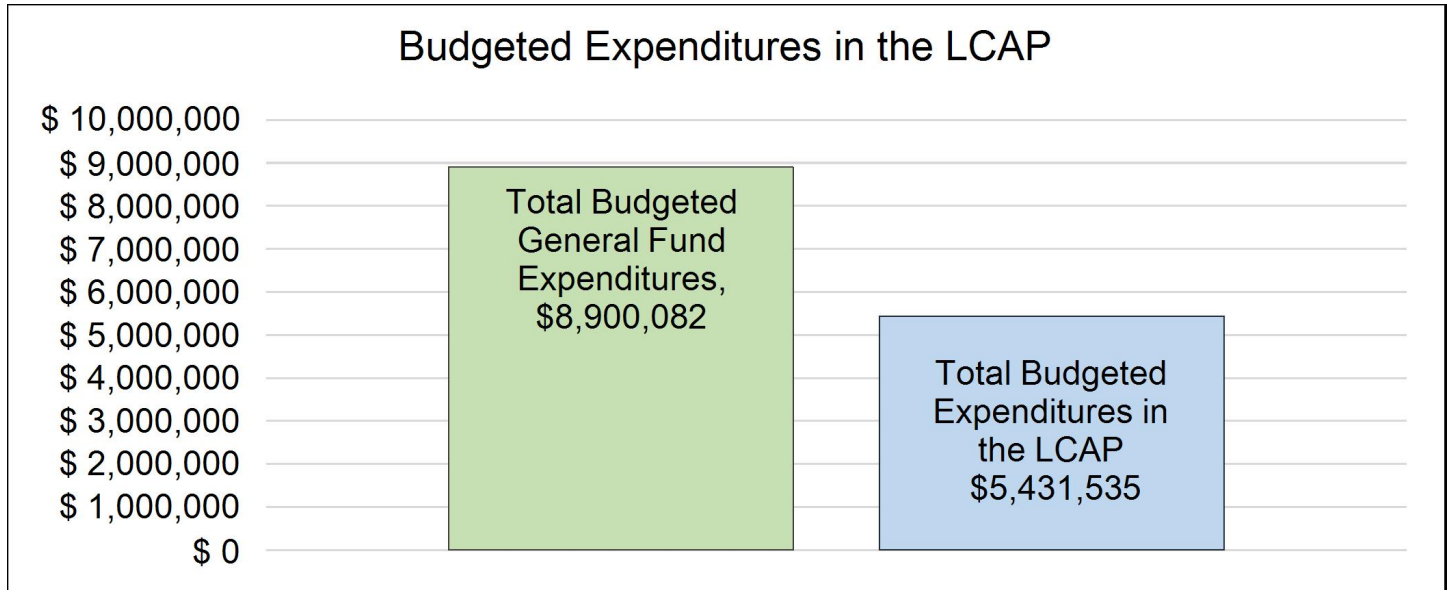


This chart shows the total general purpose revenue Aspire River Oaks Charter School expects to receive in the coming year from all sources.

The text description for the above chart is as follows: The total revenue projected for Aspire River Oaks Charter School is \$9,147,573, of which \$6,066,381 is Local Control Funding Formula (LCFF), \$2,450,429 is other state funds, \$0 is local funds, and \$630,763 is federal funds. Of the \$6,066,381 in LCFF Funds, \$1,350,788 is generated based on the enrollment of high needs students (foster youth, English learner, and low-income students).

Of that amount, \$5,431,535 is tied to actions/services in the LCAP and \$3,468,547 is not included in the LCAP. 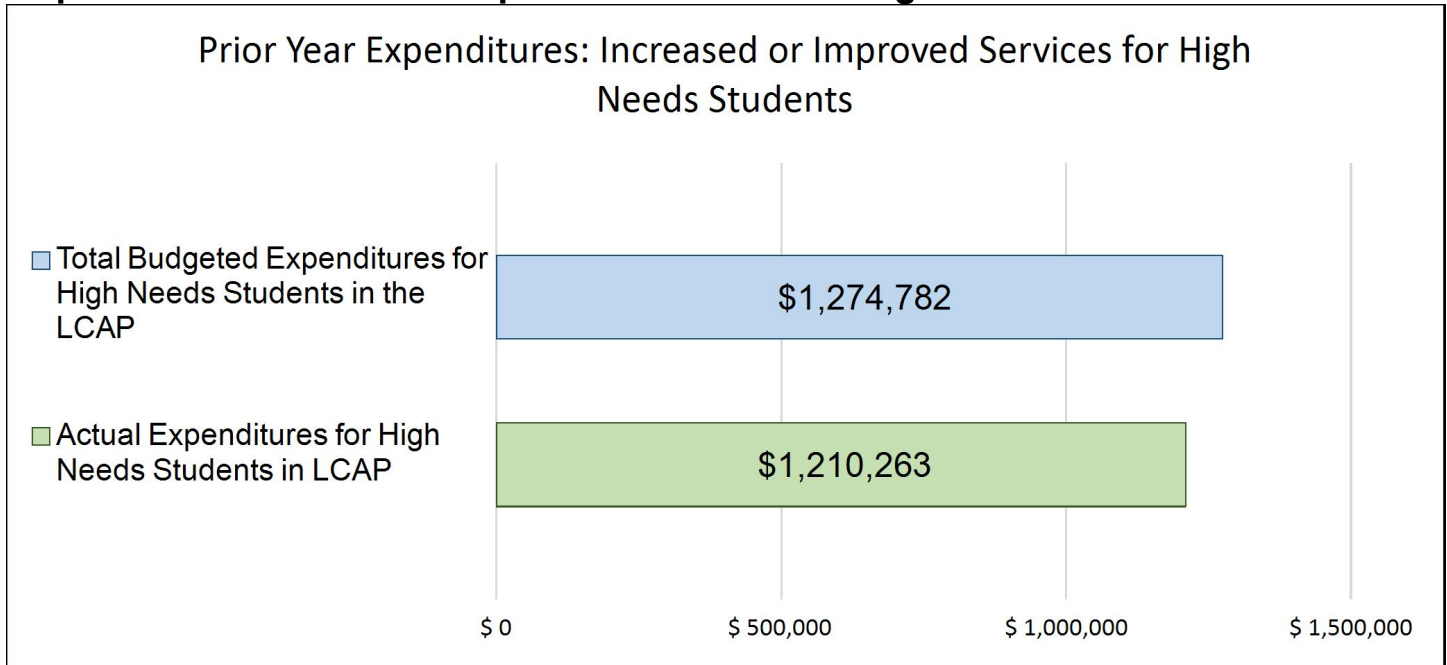

The General Fund, which covers expenses beyond the LCAP framework, encompasses a broad spectrum of services and administrative functions, including but not limited to operational costs for fundamental LEA functions such as administration, maintenance, utilities, and cafeteria services.

Increased or Improved Services for High Needs Students in the LCAP for the 2024-25 School Year

In 2024-25, Aspire River Oaks Charter School is projecting it will receive \$1,350,788 based on the enrollment of foster youth, English learner, and low-income students. Aspire River Oaks Charter School must describe how it intends to increase or improve services for high needs students in the LCAP. Aspire River Oaks Charter School plans to spend \$1,425,307 towards meeting this requirement, as described in the LCAP.

Goal Analysis

An analysis of how this goal was carried out in the previous year.

A description of any substantive differences in planned actions and actual implementation of these actions.

In the previous year, Goal one focused on ensuring all scholars are meaningfully engaged in rigorous, standards-aligned, culturally responsive academic programming. The implementation saw teachers being provided with release time for each grade level/content team to have regular lesson internalization time and support so teachers can customize grade level curriculum. In addition, we purchased needed curriculum replacements to ensure all core subjects have standards-based and board approved curriculum. Teachers are provided time in the school day to engage in weekly data discussions to analyze Common Formative Assessments and discuss next steps and supports for the students who require it. Teachers had the opportunity to attend CORE Science of Reading PD which led to higher academic achievement on I-Ready scores.

We were able to expand our Expanded Learning Opportunity Program significantly this year and making sure the program runs 30 additional days outside of the school year, providing homework support, enrichments and academic supports.

While most activities were aligned with our plan, we were not able to engage in PD around the 5 models of co-teaching as our Lead Education Specialist, resigned at the beginning of the year, which unfortunately set us back as a school on trying to implement co-teaching practices.

Additionally, although we did purchase additional EL Achieve kits and consumables, and provide designated ELD to our 135 English Learners, we were unable to provide professional development around Integrated MLL supports to our teachers.

An explanation of material differences between Budgeted Expenditures and Estimated Actual Expenditures and/or Planned Percentages of Improved Services and Estimated Actual Percentages of Improved Services.

There were no substantive differences between the budgeted expenditures and the estimated actual expenditures and/or Planned Percentages of Improved Services and Estimated Actual Percentages of Improved Service.

An explanation of how effective or ineffective the specific actions were in making progress toward the goal during the three-year LCAP cycle.

Regarding the effectiveness of our actions in meeting Goal 1 during the three-year LCAP cycle, we focused on prioritizing meaningful data discussions with teams analyzing Common Formative Assessments. Our school data across all matrix are significantly lower due to the learning loss experienced during the pandemic. Therefore, by allowing teachers access to this time, they are able to collaborate on best practices and supports for small group instruction which leads to higher student achievement. In addition, our two intervention teachers are also involved in the collaboration with teachers in order to provide additional strategies and practices.

A description of any changes made to the planned goal, metrics, desired outcomes, or actions for the coming year that resulted from reflections on prior practice.

Based on our analysis, we have made adjustments to sending the remainder of River Oaks teachers to CORE Science of Reading professional development and providing monthly professional development on the CORE Science of Reading for the coming year due to the lack of opportunity provided to teachers. To address this, we are implementing a new approach by having our Reading Interventionists, who are trained in the CORE Science of Reading, meet with teachers who are not trained to provide additional strategies, practices, ideas to help support and develop teachers reading instruction. This revised strategy aims to assist with rigor in our classes, thereby aligning more closely with our defined goals and expected outcomes.

We updated the three LCAP goals to align with our regional strategic plan, ensuring they reflect our current strategic directions and community needs. For clarity and relevance, we revised our metrics by removing those linked to discontinued assessments and enhancing those that measure local indicators, thus improving their alignment with actual educational outcomes. Furthermore, we refined our three-year outcome targets using the 5x5 dashboard to promote continuous, attainable growth and alignment with our strategic plans.

Goal Analysis

An analysis of how this goal was carried out in the previous year.

A description of any substantive differences in planned actions and actual implementation of these actions.

In the previous year, Goal 2 focused on cultivating communities that foster inclusive, joyful, and safe learning environments. The implementation saw an increase in attendance and a decrease in chronic absenteeism. As a school we developed an attendance team which created a school-wide attendance incentive program. We have grade level attendance competitions, monthly attendance awards along with a most improved student improvement of the month prize.

In addition, we have continued to strengthen and improve our MTSS process by creating cohorts of students. Our MTSS Coordinator is able to meet with teachers weekly to discuss progress monitoring and next steps. Grade level teams also meet monthly to discuss new strategies and approaches with students in the MTSS process.

The culture at River Oaks remains positive and strong. We are continuing to implement our SEL program which provides students with tools within themselves to handle situations. During our monthly assemblies, we have Student of the Month Awards which acknowledges and celebrates students who have shown these tools in and outside of the classroom. We have also continued with Kindness Week and our teachers are participating in lunch bunches with their students.

We have also added a Mental Health Therapist to our staff this year and she has been able to work with students individually and create different groups, friendship groups, girls' group, social awareness group, etc.

An explanation of material differences between Budgeted Expenditures and Estimated Actual Expenditures and/or Planned Percentages of Improved Services and Estimated Actual Percentages of Improved Services.

There were no substantive differences between the budgeted expenditures and the estimated actual expenditures and/or Planned Percentages of Improved Services and Estimated Actual Percentages of Improved Service.

An explanation of how effective or ineffective the specific actions were in making progress toward the goal during the three-year LCAP cycle.

Regarding the effectiveness of our actions in meeting Goal 2 during the three-year LCAP cycle, focusing on the chronically absent students has been very effective. This outcome can be attributed to factors such as educating our families on the importance of attendance. Teachers are also reaching out to families to connect after two consecutive absences. In our Wednesday Weekly folders, we are also sending home handouts for parents on the importance of good attendance.

A description of any changes made to the planned goal, metrics, desired outcomes, or actions for the coming year that resulted from reflections on prior practice.

Based on our analysis, we have made minor adjustments to our actions for the coming year. For actions deemed ineffective, such as providing time for teachers to review SEL data from Panorama Ed and modify SEL units, we identified the ineffectiveness was due to lack of time teachers have during their day to complete this task. To address this, we are implementing a new approach by having our Mental Health Therapist analyze the data and complete SEL lessons in classrooms and or service students who may need one on one services. This revised strategy aims to equip are students with strategies and tools to have a more positive self-identity, thereby aligning more closely with our defined goals and expected outcomes.

We updated the three LCAP goals to align with our regional strategic plan, ensuring they reflect our current strategic directions and community needs. For clarity and relevance, we revised our metrics by removing those linked to discontinued assessments and enhancing those that measure local indicators, thus improving their alignment with actual educational outcomes. Furthermore, we refined our three-year outcome targets using the 5x5 dashboard to promote continuous, attainable growth and alignment with our strategic plans.

In the previous year, Goal 3 focused on ensuring all scholars have access to a team of diverse, effective, and thriving professionals who are developed and supported to show up their best and enact culturally responsive and an- racist practices. We were able to carry out quarterly professional development around GLEAM strategies and culturally responsive teaching practices, along with giving teacher teams time to plan out GLEAM and these new strategies in their lessons. In addition, retention bonuses were given to teachers, and we had a high retention rate, with only one teacher who left Aspire.

While most activities were aligned with our plan, we were able to give our newer teachers coaching and feedback sessions every 2 weeks, teachers with 5 or more years of teaching did not receive the same amount of coaching and feedback due to lack of time. However, veteran teachers were available to the newer teachers to assist in being able to be observed and or engage in teach backs.

Regarding the effectiveness of our actions in meeting Goal 3 during the three-year LCAP cycle, quarterly staff input sessions regarding culture/climate have proven to be effective as it is an opportunity for staff to share how they are feeling about issues at the school, give time for problem solving, etc. It is evident in the high percentage rate of staff survey data that staff feels valued and safe sharing their opinions. Dibels and I-Ready Data were showing steady increases throughout the year. In addition, Panorama survey data from Winter 2024 indicates that 86% of families stated their child(ren) feel a sense of belonging and 85% of families shared that the school is preparing their child(ren) academically for the next school year.

For clarity and relevance, we revised our metrics by removing those linked to discontinued assessments and enhancing those that measure local indicators, thus improving their alignment with actual educational outcomes. Furthermore, we refined our three-year outcome targets using the 5x5 dashboard to promote continuous, attainable growth and alignment with our strategic plans.

General Information

Aspire River Oaks Charter School is a direct-funded countywide benefit charter school located in San Joaquin County. It is chartered through Lodi Unified School District.

Aspire River Oaks Charter School has been serving students in the Stockton community since 2001. This school year, we served approximately 451 students. For the 23-24 school year we will continue to serve approximately 451 students in grades TK-5. Currently, the school’s demographic profile is 38% Latino/Latina/Hispanic, 7% African American, 31% Asian, 6% White, 1% Nave Hawaiian/Other Pacific Islander, 1% American Indian/Alaskan Nave, and 13% multiple ethnicities with 76% of the student body eligible for the free and reduced priced meals program. 29% percent of students are classified as English Language Learners and 10% of our students receive Special Education services. Currently, 0% of our students are Foster Youth.

Reflections: Annual Performance

A reflection on annual performance based on a review of the California School Dashboard (Dashboard) and local data.

This year, River Oaks performance on the school dashboard highlighted both strengths and areas of challenge. For example, our English Language Learners received an orange performance level in the area of ELA. Based on this data, we increased supports for our English Language Learners by increasing designated ELD minutes in small groups. In addition, we noticed a correlation with our English Language

Learners and chronic absenteeism. English Language Learners received an orange performance level for chronic absenteeism on the 2023 Dashboard. We launched a school-wide incentive plan to encourage parents and students to attend school.

The data also includes a high-performing level in the area of math. We contribute this success with consistently looking at end-of-unit module assessments and adjusting instruction, small groups to address misconceptions, and implementing an after-school tutoring program three days a week for eight weeks.

These indicators and performance levels on the Dashboard guide our efforts in providing targeted support and interventions to address the needs of our students.
