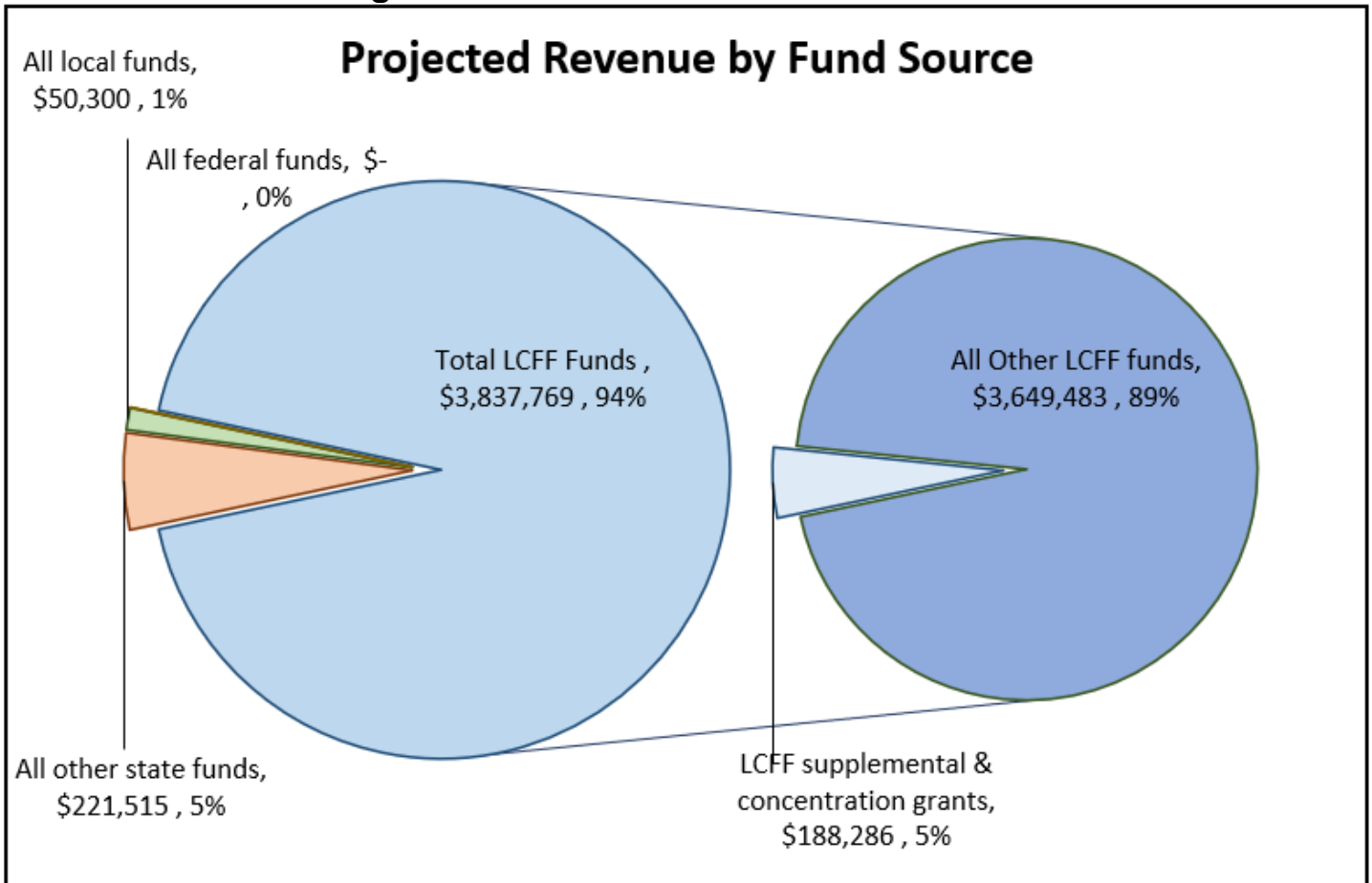

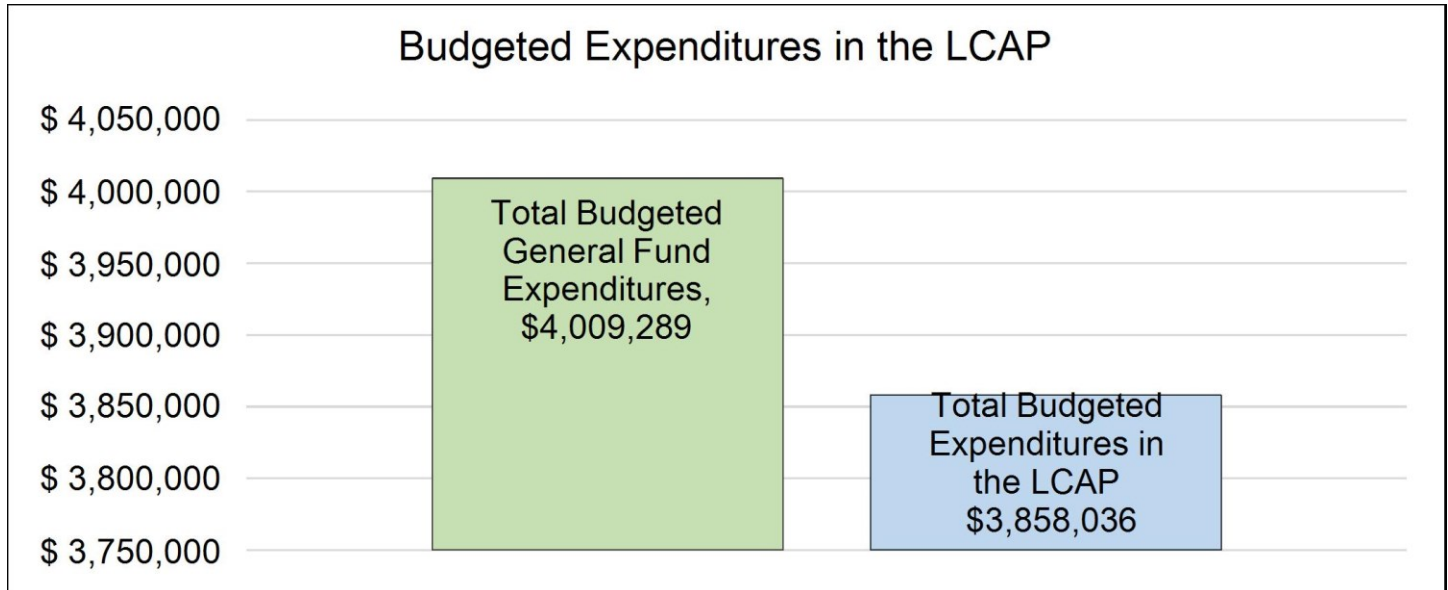


This chart shows the total general purpose revenue Escalon Charter Academy expects to receive in the coming year from all sources.

The text description for the above chart is as follows: The total revenue projected for Escalon Charter Academy is \$4,109,584, of which \$3,837,769 is Local Control Funding Formula (LCFF), \$221,515 is other state funds, \$50,300 is local funds, and \$0.00 is federal funds. Of the \$3,837,769 in LCFF Funds, \$188,286 is generated based on the enrollment of high needs students (foster youth, English learner, and low-income students).

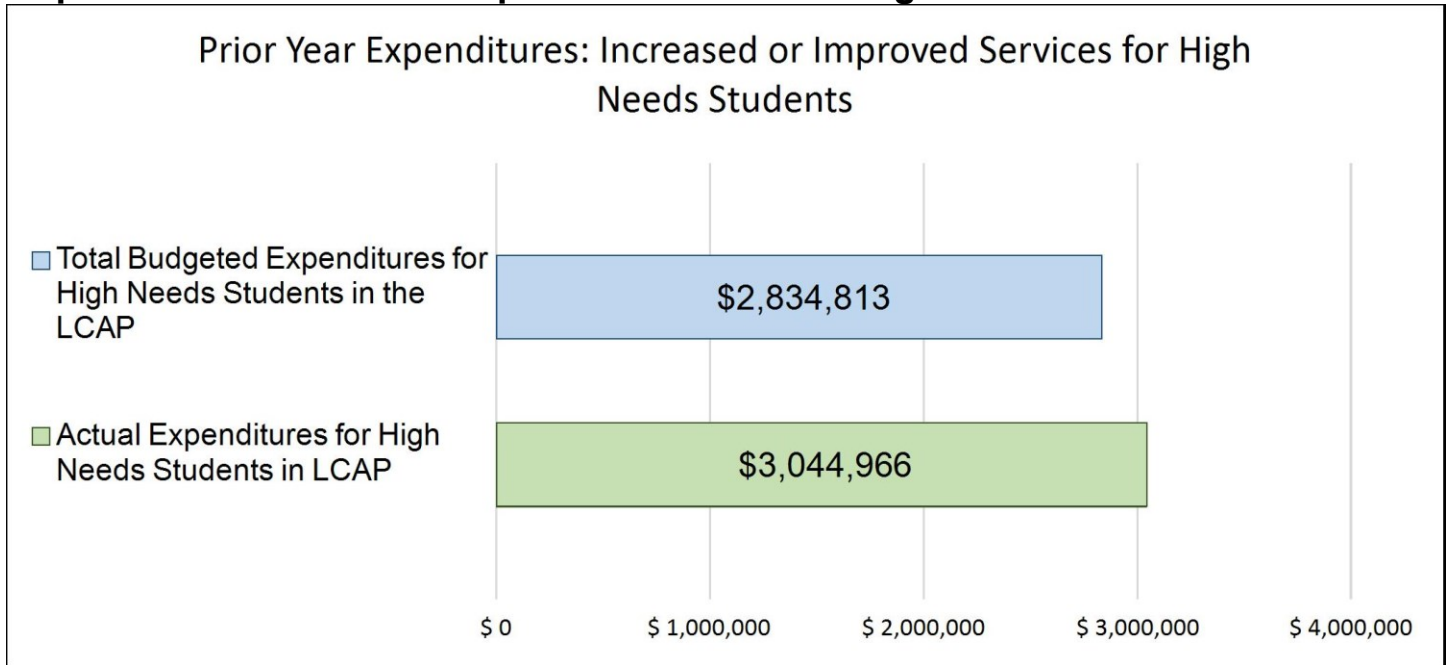

Goal Analysis

An analysis of how this goal was carried out in the previous year.

A description of any substantive differences in planned actions and actual implementation of these actions.

Eight of the nine actions were implemented as planned.

Action 1.7: When originally written into the LCAP, Math training via a partnership with UC Davis Math Project for grades K-12 was identified as the means for math professional development. Geographical limitations proved to be a limiting factor resulting in EUSD establishing a related partnership with the SJCOE Math Department who resumed the work started initially by the UC Davis Math Project.

An explanation of material differences between Budgeted Expenditures and Estimated Actual Expenditures and/or Planned Percentages of Improved Services and Estimated Actual Percentages of Improved Services.

The District has identified the material difference threshold at a 15% variance between total expected and actual expenditures for each action.

A review of the actions and any material differences are below:

Action 1.1 - A material difference of 53%, under the budgeted expenditures occurred for action 1.1. This was related to a reduction in Federal Title I funds and one-time funds, included in the LCAP, that were used for some of these expenditures.

Action 1.2 - A material difference of 26%, over the budgeted expenditures occurred for action 1.2. The district purchased more student Chromebooks than originally planned. The district also has begun replacing old classroom projectors with smart screens for instructional use. The number of these screens purchased was not accounted for in the original budget.

Action 1.8 - A material difference of 39%, over the budgeted expenditures occurred for action 1.8. The district adopted and purchased TK-8 Science and Social Science curriculum which were not in the original budget.

Action 1.9 - A material difference of 69%, over the budgeted expenditures occurred for action 1.9. The district's Supplemental funds increased over the budget year and these funds were used to purchase additional materials, supplies, and contracted services to support student learning at all school sites.

An explanation of how effective or ineffective the specific actions were in making progress toward the goal during the three-year LCAP cycle.

Upon reflection on student outcomes from the 2023-24 Local Control Accountability Plan (LCAP) a review of state and local indicators of student performance, input from educational partners, and other metrics. The action's relative effectiveness was varied. An explanation of the effectiveness or ineffectiveness of the specific actions follows.

Action 1: was effective. The district continued to implement a system of subsidized costs whereby the cost of AP tests was decreased to assist with any financial burden. AP passage rates show an increase from a 38% year 1 passage rate outcome to this year's 78.64% passage rate (Metric 4G).

Action 2: was effective. The district was able to maintain access to the necessary curriculum including access to 1:1 devices for all students as well as retire some devices that had aged beyond continued use. These student devices were replaced with new devices to maintain access to updated technology, which is a key priority (Metric 1B and Metric 2, Question 1).

Action 3: was effective. EUSD accomplished this by allowing opportunities for staff training, use of the district-adopted benchmark assessment platform, Renaissance Place, as well as the utilization of CAASPP Interim and Practice assessments (Metric 2, Question 1).

Action 4 was partially effective. As reflected by Metric 1A, 96.7% of EUSD teachers are appropriately assigned and fully credentialed in the subject areas and for the students they are teaching. This represents a 4.7% increase from the metrics baseline and a 3.7% increase from the prior school year's percentage. Thereby, showing progress and relative effectiveness of the action. However, job postings reflect that there are currently positions that have not been filled for the 2023-24 school year despite multiple measures taken to resolve the situation.

Action 5: was effective. The district has been able to maintain current levels of staffing and contracted services to provide access to a broad course of study and effectively maintain Tier II and Tier III staff and supports (Metric 1A).

Action 6: was effective. Facilities projects continue to focus on student and staff safety including the fencing project at El Portal Middle School and the remodeled Escalon High School office. The percentage of school facilities with a "Good Repair" rating is at 100% (Metric 1C).

Action 7: was effective. As measured by Metric 2, Questions 1, EUSD accomplished this by providing staff training in both the TK-8 Science and TK-8 Social Science new curricula by providing math training via a partnership with UC Davis Math Project and then with the SJCOE Math Department for grades K-12. Escalon Unified continued with the ongoing growth and evolution of Professional Learning Communities (PLC). In the summer of 2022, the district sent 50+ employees to the Solution Tree, PLC at Work Institute in Sacramento. This event, in tandem with Luis Cruz's district-wide Professional Development Day, served as the springboard for ongoing teacher and staff collaboration that ensued through the 2022-2023 school year. Collaboration days were student-focused while teachers and staff worked to answer the four PLC questions: 1. What do we want students to learn? 2. How will we know if they learned it? 3. What will we do if they did not learn it? 4.

What will we do if they already know it? Relatedly, elementary schools continued to facilitate grade-level site PLC meetings during minimum days; with the middle school and high school facilitating site content PLC meetings during their minimum days. In November 2022, a team of 20 staff attended Solution Tree's RTI at Work conference, while an additional team attended the Mathematics at Work conference also hosted by Solution Tree. The district plans on continuing the development of PLCs to ensure access to the Common Core State Standards (CCSS) for all students and ensuring that Guaranteed Standards are taught to all EUSD students.

Action 8: was effective. As indicated by Metric 1B, 100% of students have sufficient access to standards-aligned instructional materials. The district was able to adopt curriculum for two new Escalon High School classes, Digital Media and the Business and Personal Finance class, thereby providing a new elective opportunity and creating an additional option for meeting the 2-year math requirement for graduation. AP Biology had an updated curriculum adopted for implementation in the 2023-2024 school year ensuring continued alignment with the AP exam and student goals. The district completed the curriculum piloting process and adoption for TK-8 Science and Social Science. Spanish versions of both Science and Social Science were implemented along with the Spanish Language Arts curriculum, Benchmark Adelante, at the EUSD Dual Language Instruction site at Collegeville Elementary.

Action 9: was partially effective. While the action as written has been implemented (materials and contracted services to provide access to a broad course of study), Metric 7A shows mixed results. Socio-economically disadvantaged enrollment in music classes and higher-level world language classes has increased over the established baseline while enrollment in AP classes has declined from the established baseline. English Learner and Redesignated Student enrollment in higher-level world language classes has increased over baseline while enrollment in Music and AP classes has declined.

A description of any changes made to the planned goal, metrics, desired outcomes, or actions for the coming year that resulted from reflections on prior practice.

Historically, given their common demographics and seat based enrollment, the ECA LCAP essentially mirrored the EUSD LCAP with minor variations. Over the last few years there has been a significant change in ECA enrollment. ECA's homeschool program has grown significantly (24-25 expected enrollment - 363 students), while the brick and mortar, seat based program has seen a significant decrease in enrollment (projected 24-25 - 32 students). With this major program enrollment shift, coupled with the new LCAP planning cycle, it was determined ECA would maintain the same goals as EUSD, but changes in expected outcomes, metrics and actions were required to better represent and address the needs of the students in the homeschool program.

A description of any substantive differences in planned actions and actual implementation of these actions.

All five actions within goal two were implemented as planned. The district was able to support English learners through protected designated English language development time across all school sites.

An explanation of material differences between Budgeted Expenditures and Estimated Actual Expenditures and/or Planned Percentages of Improved Services and Estimated Actual Percentages of Improved Services.

The District has identified the material difference threshold at a 15% variance between total expected and actual expenditures for each action.

A review of the actions and any material differences are below:

Action 2.1 - N/A

Action 2.2 - No material difference

Action 2.3 - A material difference of 52.5%, over the budgeted expenditures occurred in action 2.3. This was due to the grants received by the high school CTE department, which allowed for additional materials and services for the CTE programs as a whole.

Action 2.4 - A material difference of 27%, over the budgeted expenditures occurred in action 2.4. This was due to the district fully implementing the ELOP program. Expenditures were more than originally budgeted. The district also made some facility upgrades for the ELOP program.

Action 2.5 - No material difference.

An explanation of how effective or ineffective the specific actions were in making progress toward the goal during the three-year LCAP cycle.

All five actions within goal two were implemented as planned. An explanation of the effectiveness or ineffectiveness of the specific actions follows:

Action 1: was effective. Districtwide CAASPP scores and STAR assessment scores have shown a decline from the established baselines. The overall decline in these scores can be directly linked to learning losses attributed to the COVID-19 pandemic. The percentage of students who meet or exceed standards on the 2023 Statewide Assessments (CAASPP and CAST) has shown improvement over the 2022 Assessments with ELA improving from 41.96% to 42.42% having met or exceeded standards, Math improving from 28.66% to 30.43% having met or exceeded standards and CAST improving from 19.09% to 23.19% (Metric 4A).

Actions 2, 4, and 5: were effective. While each addresses different actions they are related to the services they provide. The district continued to implement master schedules at the middle school and high school, which guaranteed Designated ELD was provided to English Learners in departmentalized settings. Access to direct, targeted, and explicit instruction helped the district with the reclassification process of English Learners. The 2021-2024 LCAP, maintained a focus on best instructional practices to support English learners, while also providing access to a broad course of study. Districtwide, 54% of EL students improved at least one level from the prior test administration on the ELPAC. The 54% progress shows a 9.6% improvement over the established baseline and exceeded the desired outcome for 2023-24 by 3%. EUSD has provided additional access to extended learning opportunities and intervention through the addition of targeted intervention during the school day as evidenced by site master schedules and dedicated staffing positions. Adding and maintaining credit recovery opportunities at the high school level has proven to be effective as evidenced by the district's continued graduation rate of over 92%. EUSD has provided additional access to a Multi-Tiered System of Support. This has focused on the whole child including academic, emotional, and behavioral supports. (Metrics 4E, 4F, 4F, 5E, and 8).

Action 3: was effective. The district was able to provide some access to career and technical education career exploration activities in grades Kindergarten through 8th grade, while also providing access to various Career and Technical Education Pathways at the high school level including the implementation of a Food Science Career and Technical Pathway with the aid of SSP grant funds. The percent of students who meet CSU/UC a-g college entrance requirements increased from 30.3% in year 2 to 33.3% in year 3, 36.8% of students being successful CTE completers nearly reached the 37% Desired Outcome, and the percentage of students who have completed both a-g requirements and completed a CTE pathway has increased every year of this LCAP cycle (Metrics 4B, 4C, and 4D).

Action 1: was effective. To ensure that all families had relevant information and to improve modes of communication, all District communication came through multiple channels (e.g., phone calls, emails, text messages, social media posts). In addition, information was provided both in Spanish and English to ensure that all our families had the necessary information. Community participation and engagement in school activities and events increased as a result of these efforts. EUSD utilized educational partner meetings at all sites to solicit feedback regarding the established LCAP goals and actions. Relatedly, the EUSD LCAP Educational Partner Survey was utilized to solicit feedback information from four targeted groups: students, parents, certificated employees, and classified employees. The district will continue to identify and use various modes of communication to engage educational partners while also keeping them informed.(Metric 3)

Action 2: was partially effective. EUSD experienced varying degrees of success regarding Action 2. Despite implementing PBIS Rewards and having PBIS programs at multiple sites, EUSD saw an increase in the percentage of students suspended at least once. It rose from 5.0% in 2021-22 to 6.4% in 2022-2023 (Metric 6A). Relatedly, expulsion rates increased from 0% in 2021-2022 to 0.3% in 2022-23 (Metric 6B).

Strategies targeted at increasing daily attendance were effective with the percentage of pupils attending school daily increasing from 94.47% in 2022-23 (P8) to 95.83% in 2023-24 (P6) and the percentage of students identified as chronically absent decreasing from 20.7% in 2022 to 17% in 2023.

The District continues to implement efforts to support students in meeting graduation requirements. For example, credit recovery courses were offered throughout the 2022-2023 school year to high school students who needed to make up high school courses. Summer School credit recovery as well as other credit recovery options were available to students during the 2023-2024 school year. Vista High School's role as a credit recovery site also played a significant role in providing students an opportunity to achieve graduate status. Pairing academic counseling alongside credit recovery opportunities to support our student body in meeting graduation requirements and improving postsecondary outcomes has been effective but recent data shows some mixed outcomes. District graduation rates for the 2022-23 school year revealed a graduation rate of 96.1%, which is higher than the state average of 86.4%. The graduation rate for students designated as English Learners dropped from 92.3% to 76.9% on the 2023 CADashboard. The graduation rate of students designated as socioeconomically disadvantaged decreased from 98.0% to 93.6% on the 2023 CA Dashboard. Overall, there was a decrease in graduation rates from one school year to the next. Relatedly, the high school dropout rate of 4.0%, as measured by the DataQuest 2022-23 Four-Year Adjusted Cohort Outcome, was a 2.0% increase from the previous school year's drop-out rate of 2.0%.

Plan Summary [2024-25]

General Information

A description of the LEA, its schools, and its students in grades transitional kindergarten–12, as applicable to the LEA.

The Escalon Unified School (EUSD) District was formed in 1967 and unified 8 separate districts in the greater Escalon area. Located in a rural agrarian part of Southern San Joaquin County, the district serves the greater communities of Escalon, Farmington, and Colledgeville. The district operates 4 elementary schools (Dent Elementary, Van Allen Elementary, Farmington Elementary, and Colledgeville Elementary), 1 middle school (El Portal Middle School), 1 comprehensive high school (Escalon High School), 1 continuation high school (Vista High School).

In 2012, the EUSD Governing Board approved a Charter Petition to establish the Escalon Charter Academy (ECA) as a district-sponsored Charter School. ECA was initially a brick-and-mortar-based K-8 charter school, including Dent and Colledgeville Elementary and El Portal Middle school campuses as a means to offset the district's declining enrollment. In the spring of 2013, the charter was revised to include a TK-12 homeschool option, Gateway Academy. Gateway began with 23 students, in the 2013-14 schoolyear and will serve roughly 350 homeschool students in the 2024-25 schoolyear. The brick and mortar program peaked at around 140 students in 2017-18 and in 2023-24 charter enrollment in the brick and mortar sites had decreased to just over 40 students. Part of this decline resulted from revised admission practices including greater flexibility involving intra-district transfer requests and moving non-district charter students onto interdistrict transfers.

In 2022-23, the ethnic composition of Escalon Charter Academy was 31% Hispanic and 61% White, with 3% undeclared and less than 1% across other ethnicities. In the same year, 23% of ECA students were identified as socio-economically disadvantaged, and 6% were identified as qualifying for Special Education services. Historically, as most of the charter students were attending district schools the charter's LCAP essentially mirrored the district LCAP. However, with the noted increase in enrollment in the Homeschool program, coupled with the major decrease in enrollment in the brick-and-mortar program it was determined that in the new LCAP cycle, the homeschool program would be the primary focus in developing of the new ECA 3 year LCAP.

Reflections: Annual Performance

A reflection on annual performance based on a review of the California School Dashboard (Dashboard) and local data.

Academic Performance -

As a homeschool program, ECA/Gateway has struggled to meet the 95% participation requirement for CAASPP testing, and as such the CA Dashboard doesn't truly reflect the academic performance and growth of ECA's students. When participation levels fall below 95%, every nonparticipating student is essentially assigned the lowest possible "distant from standard" score on that particular exam (ELA, 333 and math, 348). This penalty calculation ranking has had a significant impact on ECA's dashboard data. For example, in 2022-23, 178 students were eligible for CAASPP and 139 students actually took the ELA CAASPP exam. After calculating the penalty score, ECA students' overall "distance from standard" score was 54.4 points below standard. However, after calculating the "distance from standard" ranking for the 139 students who took the CAASPP, the revised ranking was 4 points below standard. Essentially, each student was penalized 50 points on the ELA exam since the school did not meet the participation rate. ECA has consistently promoted CAASPP and emphasized the consequences low participation rates will have on the school, but has never achieved more than an 80% participation rate. Families choose to homeschool for a variety of reasons, but often it is a dissatisfaction with public schooling in general, as well as required high-stakes standardized testing.

However, of the 139 3-8 students who did participate in CAASPP -

- 55.39% were ranked proficient or above in ELA
- 39.2% were ranked proficient or above in math

Both of these percentages exceeded state averages, and exceeded, or were on par, with local results. Additionally, even with the non-participation penalties, no Gateway student group was identified as Red on the CA Dashboard. As for performance rankings for unduplicated students, ECA students identified as SED represent the largest group of students in the unduplicated count representing 23.2% (73) of the school's total enrollment. 2.2% (7) were identified as ELs and .3% (1) as foster youth. In reviewing dashboard data ECA SED students outperformed all other student groups, except the Hispanic group and ranked comparably to all student groups in math. Overall CAASPP results for the SED group ranked 53.13% of this student group as meeting or exceeding standard in ELA and in math the at or above standard ranking was 31.25%.

Recognizing low participation rates will be an ongoing issue with ECA's Dashboard, ECA has implemented other measures to monitor the growth and performance of students. ECA administers Renaissance Learning's STAR assessments in Reading and Math as an alternate standardized metric to monitor student growth and performance. These assessments are administered a minimum of three (3) times a year in the fall, winter, and spring. The spring benchmark is utilized more as a summative metric and represents end-of-year student performance levels in the respective subjects. Additionally, based on STAR results and other data, students who are struggling are also assessed and progress monitored with more individualized measures (e.g. AimsWeb, Slosson, DRA, etc.).

Reviewing the 22-23 Spring STAR results with the CAASPP results showed many similarities. With over 95% of 2-11 students participating in the 2022-23 Spring STAR administration -

- 70% demonstrated proficiency in reading
- 45% demonstrated proficiency in math

Other State Indicators -

ECA has 19 students with active IEPs, 9 of whom are speech only. Regardless, ECA's homeschool program ensures that each student receives the needed support and resources to support their programming needs.

Attendance - As a homeschool, ECA has nearly perfect attendance and had a green status with a 3.5% Chronic Absenteeism rating in 22-23. Most attendance issues are generated by +/- 40 students who remain in the brick-and-mortar program and attend a physical site.

Suspension rate - ECA received a green status with a .6% suspension rate. Like students identified as Chronically Absentee, all suspended students were enrolled at one of the ECA brick-and-mortar campuses.

Graduation Rate, College/Career, and EL Progress - Although ECA has maintained a 100% graduation rate, this is not always evidenced on the dashboard due to the small reporting samples.

This is the same case with the EL progress indicator as there were only 4 students in the EL subgroup in the 23-24 school year.

ECA is quite fortunate to have such an outstanding and collaborative staff with a broad range of grade-level experience and expertise. For example, we have a cadre of teachers with exceptional foundational literacy development skills who support their fellow teachers and ECA families with students in the early primary grades. On the other hand, we have a small group of teachers with single-subject credentials who likewise support their fellow teachers and ECA families with students in the middle and high school grades. The diversity of our staff is a critical part of Gateway's success because families don't always come in grade-level clusters. It is not uncommon for a teacher to have several families with 2-3 grade spans (e.g. primary, elementary, high school) on their caseload, and they know if they have an unfamiliar issue, ready support is always available. The mindset that these are all "our" kids and the high level of collaboration and collegiality extends deeply into our overall school culture and positive relationships established with our families. While there is no formal referral process in place, reviewing the annual New Family Enrollment Interest form, reflected that a majority of respondents heard about Gateway from a current family. Given ECA's rate of growth over the past few years, it is apparent that good things are happening.

Standards without standards - Parents choose to homeschool their children for several reasons, but one primary reason is the disdain felt towards a standards-based education mandate. ECA through the use of specific grade-level learning targets or "I Can" statements, regular benchmarking of student performance, and support and monitoring of parent-selected curricular materials, can effectively assess a student's access and progress toward grade-level standards throughout the year. Our primary focus is on student learning and progress, and not the structure of the curricular materials. This focus on learning, aligned with specific learner needs, with targeted skill development and ongoing progress monitoring, has been effective in showing that students are not only accessing the standards, but that they can also demonstrate their ability to meet them.

While difficult to quantify, the courses of study available to ECA Homeschool students is as individualized as the student. For example, we had a 10th grade student who was completing an aviation ground school program. After reviewing the curriculum, scope and sequence of the program, and total program hours, the student earned a full year of elective high school credit and has completed the first step towards achieving his career goal of becoming a licensed pilot. Another student completed a year long program in Barn Management, which was a foreign concept in a traditional sense for the school, but was actually quite rigorous, demanding, and complex. Additionally, with the range of available online course options that currently exist, from Edgenuity, our inhouse option, to Outschool, ECA students have an extensive range of course options to choose from. Not only do these courses augment and extend their core curriculum, it also allows them to explore, plan, and prepare for their post-high school career goals.

As a Homeschool, facility needs differ from traditional school settings. The current campus layout is adequate for our current program, but the campus proper is in need of renovation and upgrades to better support our program. Beginning in the summer of 2024, the campus will be receiving infrastructure upgrades and repair. Additional storage space and hands on learning labs (e.g. school garden, maker lab) and grounds improvements for PE and other extracurricular activities will also be included in this upgrade. Not only will the physical appearance of the campus be improved, but the revised layout will better support the needs of our students.

Given the nature of the ECA homeschool program the concept of "School Community" is the backbone of our program. Working hand in hand with parents in one of the most complex yet rewarding experiences, the education of your child, is why ECA's main focus is on building positive relationships with our families and focusing on their Child(ren)'s' growth and achievement. A critical piece of these relationships involves listening to our families and responding to their concerns and needs through evaluation of program options and revising or clarifying what we can and cannot to address these concerns and needs. In the development of the LCAP, we recognize that our educational partner engagement isn't limited to annual surveys, meetings, etc., but also includes the ongoing feedback and input we receive from our partners on a continual basis. In developing the new 3 year ECA LCAP our educational partner input can be directly linked to to the following goals and actions.

GOAL 1 - Escalon Charter Academy will provide the necessary support, resources, and staffing to make all students Career and College Ready by implementing a multi-tiered system of support that increases student achievement, provides access to a well-rounded education, and exposes students to the rigorous Common Core State Standards.

GOAL 2 - Escalon Charter Academy will implement a multi-tiered system of support that provides all students access to rigorous academic programs and develops the requisite skills to be Career and College Ready upon graduation.

GOAL 3 - Escalon Charter Academy will enlist input and participation from educational partners to create welcoming student-centered learning environments that are effective and engaging.

Key trends and patterns identified during Educational Partner participation -

Both staff and parent input overwhelmingly remarked about upgrading the ECA facilities. On the annual LCAP Educational Partners Survey 60% of the ECA parent responses strongly disagreed or disagreed that the school's facilities were up to date. On the staff side, 100% of ECA staff shared their dissatisfaction with the status of ECA facilities during staff meetings, informal discussions, and often on Monday morning when the staff discovered the damage our woodpecker friends inflicted over the past weekend. In addition to the condition of the facilities, staff, and parents have also shared concerns about the ease of access to the campus and lack of perimeter control.

While over 90% of the respondents on the mid-year parent survey felt satisfied (13%) or very satisfied (79%) with ECA's Enrichment classes, nearly a third of the respondents (32%) provided recommendations about improving the enrichment program. The common theme of these suggestions centered on improving offerings in the area of technology, and science.

While the main focus of professional development over the past few years has been the establishment of Professional Learning Communities, staff feedback in staff meetings, principal advisory meetings, and evaluation conferences has indicated a need for additional staff development focusing more on effective homeschooling strategies and practices including enrichment and support.

Staff and parent feedback from home visits, mid-year parent surveys, principal's advisory, and staff meetings have indicated a need for more strategic and timely intervention for struggling students. Additionally, in response to these concerns, and an unexpected increase in requests for SSTs and assessments for special education eligibility, in the first half of the 2024 school year, during staff collaboration time, a systematic process for identifying students (and parents) needing additional Tier one support was developed this past year. However, the lack of staff experience and training in using progress monitoring tools and practices made it challenging to effectively identify, support, and progress monitor the students' areas of specific need.

Action - 1.5 - Facility Maintenance

While ECA's FIT report identifies ECA facilities as being in "Good" repair, this rating does not adequately describe their current state. Two classrooms were recently installed and are in like new condition, but 4 classrooms and the main office are located in portables that are over 25 years old. Combined with the age of the buildings and the campus's rural location the facility has been exposed to drainage issues, woodpeckers, pest infestations, and extensive dry rot. Their current condition is more aligned with educational partner feedback than it is with ECA's annual FIT report. To address this area, ECA, with the support of district administration, will undertake a major facilities upgrade project this summer including replacement of all siding, floor covers, and ceiling tiles in the main office and 4 of the classrooms. This upgrade will also include an upgrade to perimeter fencing and grounds to enhance campus safety, security, and visitor access.

Action - 1.2 - Access to Technological Supports and Literacy

32% of survey responses from the mid-year Parent survey support more opportunities indicated support for expanding ECA's site-based enrichment program with the common theme of providing more opportunities for STEM and Technology classes for students. This past year STEM and Technology units were successfully piloted during the enrichment program, and staff are also supportive of adding additional classes in this area. Additionally, ECA's enrollment increase necessitated hiring two additional consulting teachers increasing the total number of Consulting Teachers on the ECA teaching staff to 14. The increase in staffing has also necessitated a restructuring of the enrichment program schedule which will also provide a broader range of course offerings in the 5-12 grades and regularly scheduled times for student intervention and parent support sessions. STEM and technology options will also be increased in this new format. In particular, one staff member has developed a comprehensive plan for a Maker Space Lab including 3D printers, robotics, electronics, and similar materials. The range of learning opportunities this lab will provide will add another dimension to the ECA enrichment program.

Action - 1.6 - Targeted Professional Development

As ECA has grown over the years and added new staff, a common refrain new staff share is how different their new role is compared to their former traditional classroom setting. With 12-15 families and 22-25 students spanning various grades per caseload, the consulting teacher must be familiar with a range of curricula across different grade levels and content, as well as have a firm grasp of the various grade level learning expectations in each content area. And while the consulting teacher promotes and supports each student's learning, they must often provide similar support to the parent, or more formally, the student's "Teacher of Record". The "Teacher of Record" is not a credentialed teacher, and as such, does not typically have a specialized instructional skill set to draw upon when engaging with their student (child). Things like the layout and structure of a curriculum, awareness of learning styles (theirs and the students), assessment practices, and the like are not common understandings for them. To better support both the parents and students on their caseloads ECA will focus on targeted PD offerings that will increase their ability to more effectively support their students and parents on their caseloads.

Additionally, related to actions 1.6 and 1.2 the identification and support of student academic needs was another common theme in the feedback provided by staff and parents alike. With the recently developed systematic approach to providing targeted and timely support to ECA's struggling students in place, the next step requires deepening staff understanding in the application of adopted progress monitoring measures (e.g. Aimsweb, DRA2) and appropriate instructional practices and materials to support identified areas of deficiency. In addressing this concern, additional professional development on the available tools and supports will be provided to all Consulting Teachers.

Action 3.2 - Positive, Effective and Engaging Learning Environments

Parent responses from the mid-year Parent survey were asked to state their preferred means of staying connected with the school program. While most respondents took it in a communications context by indicating their preferred means of communicating with the school (text messaging and email), in the comments section several parents responded in a different context and emphasized maintaining "connection" with the school and greater school community. The central theme in their responses was making and maintaining connections with parents and families as part of the greater school community. This theme was also brought up in the Parent Leadership Team's LCAP meeting when they shared the need to focus outreach on creating more opportunities for parents to connect and share with each other. An outcome of the Parent Leadership Team LCAP meeting was for the Team and the school to collaborate and facilitate more parent social-based activities. For example, on enrichment days many parents informally gather at the local park after class and socialize while their children play. The Parent Leadership Team suggested that rather than an informal, happenstance approach, the school could help them promote and formalize an "After Class Park Meet and Greet" type of event. For the school's part, ECA could provide support by integrating activities like a student recognition event or pizza lunch into these meet and greets. In this context, beginning in the fall of 2024 ECA will partner with our Parent Leadership Team and assist them in facilitating more parent community-building activities.

The actions within this goal are designed to provide our students with safe school facilities, provide access to highly qualified teachers, and the necessary instructional support and materials to promote mastery of the adopted academic standards. Furthermore, the actions within this goal support ongoing targeted professional development to support best instructional practices while allowing for differentiated supports consistent with individual student needs. We will monitor and evaluate the actions by collecting and reviewing data including instructional materials and technology inventory, staff participation in professional learning and facility maintenance reviews as well as solicit educational partner feedback throughout the year.
