# MINIMUM QUALIFICATIONS - EDUCATION AND/OR TRAINING:

Possess a Bachelor's Degree from an accredited college or university with an emphasis in appropriate field. Appropriate California teaching credentials.

## **DESIRABLE QUALIFICATIONS - EDUCATION AND/OR TRAINING:**

Possess a Master's Degree in special education or related field. Training in discrete trial instructional methodologies, alternative communication systems.

#### **DESIRABLE EXPERIENCE:**

Experience with severely handicapped; behaviorally challenged; and/or autistic students. Experience with or interest in discrete trial instructional strategies, alternative communication systems, assistive technology.

#### CREDENTIALS AND/OR SKILLS AND ABILITIES:

Possession of or qualification for a California Specialist Credential, Severely Handicapped. Commitment to education in least restrictive, normalized settings. Ability to function as a member of an educational team. Sign language skills are strongly desired. Willingness to develop such skills is essential. Strong behavior management, positive discipline skills. Ability to coordinate and/or direct the work of instructional assistants, support personnel. Be flexible and receptive to change.

#### **SUMMARY OF POSITION:**

Under supervision of Special Education Program Administrator, will provide quality education to severely handicapped students, ages 18 months to 22 years, through a commitment to team participation in planning and implementation of student programs; a functional, community based curriculum; communication and social skill development; interagency cooperation, and a strong parent-teacher-student linkage. Opportunities exist to develop and experiment with adaptive technology, vocational education, and integration with non-handicapped populations. Does related work as required.

#### **ESSENTIAL FUNCTIONS:**

Essential functions may include, but are not limited to:

- 1. Prepare student education plans in consultation with parents and IEP team members.
- 2. Design instruction and record progress of students.
- 3. Act as coordinate of IEP implementation, directing work of instructional assistants, and monitoring service from support personnel.
- 4. Maintain appropriate student data and other records and submit reports as required.
- 5. Develop community based instructional plan where necessary and appropriate.
- 6. Develop communication systems for use in community and campus settings.
- 7. Manage classroom organization.
- 8. Articulate curriculum between and among student levels.
- 9. Perform other related duties as assigned.

## **PHYSICAL REQUIREMENTS:**

Employees in this position must have the ability to:

- 1. Facility to sit at a desk, conference table or in meeting rooms of various configurations for varying amounts of time.
- 2. Facility to see, read, and distinguish colors, with or without vision aids, instructional materials, rules, and policies and other printed matter.
- 3. Facility to speak in audible tones so that others may understand clearly in normal conversations.
- 4. Facility to walk on uneven terrain, play yards and school grounds.
- 5. Physical agility to lift and carry from 20-40 pounds; and to bend, stoop, walk, reach overhead, and stand as many as four hours per day.
- 6. Physical agility to push/pull, squat, twist and turn.

# WORK ENVIRONMENT:

Employees in this position will be required to work indoors in a standard classroom environment and outdoors as instruction requires. Comes in direct contact with students, SJCOE and district office staff, and the public.
